1. LOCAL INTEREST INFORMATION

The following crimes and offences were reported to the Police in the Inverurie area which occurred between 15 May to 19 June, 2017.

BREACH OF THE POLICE/THREATENING AND ABUSIVE BEHAVIOUR.

Following what has been a prolonged and proactive enquiry into the disturbances which took place around 5 weeks ago, DC David Calvert tells me that 34 youths have now been traced and charged with various offences I have seen him day in and day out at the office doing the paperwork in relation to this incident and going to and coming back from the several arrests he and his colleagues in our Domestic, alcohol and violence reduction unit.

I think that is an excellent result by these officers proving that we are here to keep the public as safe as possible.

Divisional Commander Murray Main has ensured that officers were drafted into the Garioch area in the days and weeks following this disturbance so Hi Viz patrols could be seen in the area and also deter any repeat. This appears to have worked due to rumoured fights in Inverurie not taking place.

ASSAULTS

There have been 11 assaults reported, 9 have been detected and offenders reported to the Fiscal. One was a serious assault whilst 4 were domestic related.

VANDALISM

9 vandalisms were reported with one closed as undetected. These others are still under investigation, 2 occurring at local schools which again, are going to see patrols target youths in the evenings who appear to be the main issue.

THEFTS

There have been 8 thefts reported, 10 shopliftings of which 7 have positive leads.

DRUGS

6 people have been reported to the courts over the last month in connection with possession

of class B controlled drugs.

ROAD TRAFFIC

Our Divisional and Road Policing officers have been proactive in and around Inverurie. They have use of unmarked high performance cars which regularly are used to catch drivers on their mobile phones, speeding etc.

2 reports have been submitted for dangerous driving, 2 for careless driving and 1 for disqualifying driving.

There are 3 reports of submitted for driving with no insurance and 1 having no MOT.

Enquiries are ongoing regarding 6 incident of failing to stop at the scene of an accident and numerous Fixed Penalty Tickets for speeding and other motoring offences.

3 drivers each received a £200 fine and 6 penalty points for driving whilst using a mobile phone.

ANTI - SOCIAL

Fixed penalty notices were given to 4 persons for urinating in a public place.
